At the Drawing (Paper) Show, we value your privacy and are committed to protecting your personal data. This privacy notice outlines how we collect, use, store, and protect your information when you join the Directory of Drawing Artists

1. Data Collection

Personal Information:

When you have been invited to join the Drawing (Paper) Show's Directory of Drawing Artists, we collect the following personal information:

- Name
- Contact details (email, postal address)
- Artistic profile information (website links, social media handles)

When you sign up to the Drawing (Paper) Show's mailing list we will collect the following personal information:

- Name
- Contact details (email address)

2. Use of Data

We use your personal data for the following purposes:

Directory of Drawing Artists:

- To create and manage your account
- To display your profile in our online directory
- To communicate with you about your account, including updates.
- To improve our services and website functionality
- To comply with legal obligations

Drawing (Paper) Show's mailing list:

- to provide service updates or marketing purposes.

3. Data Sharing

We do not sell or rent your personal data to third parties. We may share your information with:

- Service providers who assist in operating our website and mailing list
- Legal authorities if required by law or to protect our legal rights

4. Data Security

We implement appropriate technical and organisational measures to safeguard your personal data against unauthorised access, alteration, disclosure, or destruction. However, no internet transmission is completely secure, and we cannot guarantee the absolute security of your data.

5. Data Retention

We retain your personal data for as long as you wish to be on the Directory of Drawing Artists, or for as long as we are able to fund the Drawing (Paper) Show and the Directory of Drawing Artists.

6. Your Rights

Under the UK General Data Protection Regulation (GDPR), you have the following rights regarding your personal data:

- **Access:** You have the right to request access to the personal data we hold about you.
- **Correction:** You have the right to request the correction of any inaccurate or incomplete data.
- **Deletion:** You have the right to request the deletion of your personal data, subject to certain conditions.
- **Restriction:** You have the right to request the restriction of processing your personal data.
- **Objection:** You have the right to object to the processing of your personal data.
- **Portability:** You have the right to request the transfer of your data to another organisation.
